

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0998

*Affirmed
Late Request for Hearing Dismissed*

PROCEDURAL HISTORY: On September 5, 2019, the Oregon Employment Department (the Department) served notice of a wage and potential benefit report concluding that claimant did not qualify for unemployment insurance benefits. On September 16, 2019, the wage and potential benefit report became final without claimant having filed a request for hearing. On September 27, 2019, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 30, 2019 issued Order No. 19-UI-137293, dismissing the request as late without good cause. On October 16, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDING OF FACT: Claimant filed her request for hearing on the September 5th wage and potential benefit report because, after receiving the report, she "was unaware that is what the next step would be until" she "called to check the status on 9/25/2019 and was informed that" she "needed to appeal." Exhibit 2. However, the wage and potential benefit report stated, "THIS REPORT BECOMES FINAL UNLESS YOU REQUEST REDETERMINATION OF THE REPORT OR REQUEST A HEARING WITHIN 10 DAYS." Exhibit 1.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

The Department's wage and potential reports become final unless a party files a request for hearing within 10 days after the date the report is mailed. ORS 657.266. ORS 657.875 provides that the deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Here, claimant failed to show that it was beyond her reasonable control to read and understand from the wage and potential report that if she disagreed with the report, she needed to request a hearing by September 16, 2019. And although claimant's failure to file a timely request for hearing was a mistake, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Claimant therefore failed to establish good cause for filing her request for hearing late, and the request is dismissed.

DECISION: Order No. 19-UI-137293 is affirmed.
