

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1009

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 22, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision assessing 52 penalty weeks (decision # 194138). On July 12, 2018, decision # 194138 became final without claimant having filed a request for hearing. On September 20, 2019, claimant filed a late request for hearing. On September 27, 2019, ALJ Kangas issued Order No. 19-UI-137248, dismissing claimant's request for hearing, subject to their right to renew their request by responding to an appellant questionnaire by October 11, 2019. On October 17, 2019, Order No. 19-UI-137248 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On October 18, 2019, claimant filed a late application for review with EAB. On October 24, 2019, EAB emailed claimant a notice of receipt of the application for review, which mistakenly stated that the application for review was timely.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 19-UI-137248 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

With claimant's application for review, claimant submitted a response to the appellant questionnaire. Claimant stated in the questionnaire that they believe they had filed a timely request for hearing because "I have fax everything and talked with I beli[e]ve Hernandez." In response to why claimant believed that they had good cause for filing their hearing request late claimant responded "I [d]on't beli[e]ve I was late cause I got approved for my unemplo[y]ment [b]enefits." Claimant's responses address the late request for hearing on decision # 194138, and not why they filed a late application for review of Order

No. 19-UI-137248. Claimant did not provide an explanation as to why the application for review was filed after the filing deadline expired. Claimant therefore failed to establish good cause to extend the October 17 filing deadline to October 18, 2019.

DECISION: The application for review filed October 18, 2019 is dismissed. Order No. 19-UI-137248 remains undisturbed.
