

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1015

Affirmed
Disqualification

PROCEDURAL HISTORY: On August 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged not for misconduct within fifteen days of a voluntary quit without good cause (decision # 110344). Claimant filed a timely request for hearing. On October 2, 2019, ALJ L. Lee conducted a hearing, and on October 4, 2019, issued Order No. 19-UI-137559, affirming the Department's decision. On October 22, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.¹

DECISION: Order No. 19-UI-137559 is affirmed.

¹ It is not good cause to leave work to accept an offer of other work unless the offer is definite. OAR 471-030-0038(5)(a) (December 23, 2018). Although Order No. 19-UI-137559 reasoned that claimant's decision to quit was "premature" and that waiting to quit until he "secured" a new job was a reasonable alternative to quitting, the order did not specifically address 471-030-0038(5)(a). Order No. 19-UI-137559 at 5. When claimant left work, it was based on the mere possibility that another employer would offer him work. The other employer had not yet offered claimant work, let alone made a definite offer of work. Therefore, to the extent claimant left work to accept other work, he did not quit work with good cause.
