

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1017

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On July 31, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information requested by the Department, and therefore was denied benefits from July 21 through July 27, 2019, and until she provided the information. On August 20, 2019, the July 31, 2019 decision became final without claimant having filed a request for hearing. On August 28, 2019, claimant filed a late request for hearing. On September 4, 2019, ALJ Kangas issued Order No. 19-UI-136062, dismissing claimant's request for hearing, subject to her right to renew her request by responding to an appellant questionnaire by September 18, 2019. On September 16, 2019 claimant filed a timely response to the appellant questionnaire. On September 17, 2019, the Office of Administrative Hearings (OAH) cancelled and vacated Order No. 19-UI-136062, and served notice of a hearing scheduled for September 24, 2019. On September 24, 2019, ALJ Snyder conducted a hearing, and on October 2, 2019 issued Order No. 19-UI-137424, re-dismissing claimant's late request for hearing as without good cause. On October 15, 2019, claimant filed a timely application for review of Order No. 19-UI-137424 with the Employment Appeals Board (EAB).

EAB considered the entire hearing record. Based on a *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-137424 is affirmed.
