

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1021

Affirmed
No Disqualification

PROCEDURAL HISTORY: On September 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 100247). Claimant filed a timely request for hearing. On October 11, 2019, ALJ Scott conducted a hearing, and on October 16, 2019, issued Order No. 19-UI-138186, concluding claimant quit work with good cause. On October 22, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB considered the employer's written argument in reaching this decision to the extent it was based on the record. The employer asserted that it did not deny claimant's request to work fewer hours, and that the employer accommodated claimant's medical conditions by allowing her to work fewer hours, use paid time off, work from home, and attend doctor appointments. The order under review did not find as fact, or rely on reasoning that the employer denied claimant's request to work fewer hours, thereby foreclosing that alternative for claimant. However, that claimant apparently already had received those accommodations from the employer, yet still experienced stress from work such that she had to go to the emergency room and her doctor advised her to quit her job, supports the order's conclusion that the risk claimant's work posed to her health was of such gravity that claimant had no reasonable alternative but to quit work when she did.

The employer also argued that claimant's health symptoms were attributable to different medical conditions that she did not disclose at hearing and were due to claimant's "diet and lifestyle choices," and "interpersonal relationships." Employer's Written Argument. As to the truthfulness of claimant's testimony about her medical conditions and symptoms, the record does not offer a basis to doubt claimant's credibility or accuracy regarding her health conditions and symptoms. Claimant's "diet and lifestyle choices" or "interpersonal relationships" are not at issue here. The record established that claimant experienced Transient Ischemic Attacks (TIAs) and other health complications induced by stress, and that her work caused or aggravated her stress. For that reason, claimant had no reasonable alternative but to follow her doctor's advice and leave work. Claimant therefore had good cause to leave work when she did.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-138186 is affirmed.
