EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1051

*Affirmed
Late Request for Hearing Allowed
Overpayment, No Penalties*

PROCEDURAL HISTORY: On August 29, 2019, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work and not eligible to receive unemployment compensation benefits from February 17, 2019 through August 24, 2019. On August 30, 2019, the Department served notice of another administrative decision assessing a \$3,797 overpayment, \$1,139.10 monetary penalty, and 26 penalty weeks (decision # 193760). On September 5, 2019, 2019, the Department served notice of another administrative decision amending decision # 193760 and assessing a \$4,328 overpayment, \$1,298.40 monetary penalty, and 29 penalty weeks (decision # 194114). On September 18, 2019, the August 29, 2019 decision became final without a request for hearing having been filed,¹ and on September 25, 2019, decision # 194114 became final without a request for hearing having been filed. On October 3, 2019, claimant filed a late request for hearing on decision # 194114.

On October 24, 2019, ALJ Snyder conducted a hearing.² and on October 30, 2019, issued Order No. 19-UI-138913, allowing claimant's late request for hearing on decision # 194114 and modifying decision # 194114 to assess a \$4,328 overpayment, but no penalties. On November 6, 2019, claimant filed an application for review of Order No. 19-UI-138913 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-138913 is affirmed.

¹ If claimant wants to contest the Department's August 29, 2019 decision finding her not available to work, which caused the overpayment, claimant may contact the Department to request a hearing on that decision.

² Order No. 19-UI-138913 mistakenly stated that the Department did not participate in the hearing. The Department participated in the hearing, and was represented by Terri Warren.
