EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-1056

Affirmed Disqualification

PROCEDURAL HISTORY: On September 20, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 113604). Claimant filed a timely request for hearing. On October 17, 2019, ALJ Shoemake conducted a hearing, and on October 24, 2019, issued Order No. 19-UI-138662, affirming the Department's decision. On November 4, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

FINDINGS OF FACT: (1) Carz Planet LLC employed claimant from June 24, 2019 to July 28, 2019 as a sales manager.

(2) The sales manager was a commissioned based position. Claimant was told that his pay would be between \$8000 to \$10,000 per month.

(3) After approximately one month, claimant had earned \$3400 as a sales manager. On July 24, 2019, the owner of the business told claimant that she could not afford to pay claimant under the current pay plan and eliminated the sales manager position.

(4) The employer offered to reassign claimant a salesperson position that paid the higher of minimum wage or twenty-five percent of the profit on each car claimant sold.

(5) Claimant anticipated experiencing a substantial reduction in pay if he worked as a salesperson instead of a sales manager. On July 28, 2019, he declined the salesperson position and quit his job.

CONCLUSIONS AND REASONS: Claimant voluntarily left work without good cause.

A claimant who leaves work voluntarily is disqualified from the receipt of benefits unless they prove, by a preponderance of the evidence, that they had good cause for leaving work when they did. ORS 657.176(2)(c); *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). "Good cause . . . is such that a reasonable and prudent person of normal sensitivity, exercising ordinary common sense, would leave work." OAR 471-030-0038(4) (December 23, 2018). "[T]he reason must be of such gravity that the individual has no reasonable alternative but to leave work." OAR 471-030-0038(4). The standard is objective. *McDowell v. Employment Department*, 348 Or 605, 612, 236 P3d 722 (2010). A claimant who quits work must show that no reasonable and prudent person would have continued to work for their employer for an additional period of time.

Claimant quit his job in part due to his perception that the elimination of his sales manager position and reassignment to a salesperson position would result in too drastic a reduction in his income. Good cause may exist when a claimant's pay is reduced, but not when pay is reduced as a result of a transfer, demotion, or reassignment. OAR 471-030-0038(5)(d)(A). Claimant therefore did not establish good cause to quit work because of a reduction in pay.

Claimant testified at the hearing that if the employer had not eliminated his sales manager position he would not have quit his job until he found another one. Audio Recording at 15:05 to 15:35. However, the record also does not show that claimant's reassignment created a grave situation that left claimant no other alternative but to quit work. His perception of income loss was speculative since he never worked in the salesperson position for the employer. Additionally, claimant would have had a guaranteed income as a salesperson, because the employer paid salespeople the higher of either minimum wage or twenty-five percent of the profit on each vehicle he sold. Given that the salesperson job came with a guaranteed income, it seems more likely than not that a reasonable prudent person concerned about his earnings would opt to have a guaranteed income rather than quit his job and have no income at all.

Claimant has not met his burden of proof that he faced a situation of such gravity that he had no reasonable alternative but to quit. For those reasons, claimant voluntarily left work without good cause. Claimant is disqualified from receiving benefits based on this work separation.

DECISION: Order No. 19-UI-138662 is affirmed.
