

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1057

Affirmed
Order No. 19-UI-136650 – No Disqualification
Order No. 19-UI-138846 – Request to Reopen Denied

PROCEDURAL HISTORY: On August 21, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 101537). Claimant filed a timely request for hearing. On September 5, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 16, 2019. On September 10, 2019, the employer representative filed with OAH a requested to postpone the hearing. OAH denied the request. On September 16, 2019, ALJ Murray-Roberts conducted a hearing, at which the employer failed to appear, and on September 18, 2019 issued Order No. 19-UI-136650, concluding that claimant was discharged but not for misconduct and therefore was not disqualified from receiving benefits. The employer filed a timely request to reopen the September 16, 2019 hearing. ALJ Kangas considered the employer's request, and on October 28, 2019 issued Order No. 19-UI-138846, denying the request. On October 31, 2019, the employer filed a timely application for review of both orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Order No. 19-UI-136650 and Order No. 19-UI-138846. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0157 and 2018-EAB-1041).

EAB reviewed both hearing records. EAB considered claimant's and employer's written arguments, to the extent that they were based on the hearing record and relevant to the issues before EAB. EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2). On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 19-UI-136650 and No. 19-UI-138846 are affirmed.
