

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1062

Affirmed
No Disqualification

PROCEDURAL HISTORY: On August 16, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision that allowed claimant benefits, concluding the employer suspended claimant, but not for misconduct (decision # 115234). The employer filed a timely request for hearing. On September 13, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 27, 2019. On September 27th, the employer failed to appear at the hearing, and ALJ S. Lee issued Order No. 19-UI-137246, dismissing the employer's request for hearing for failure to appear. On October 2, 2019, the employer filed a timely request to reopen the September 27th hearing. On October 11, 2019, OAH served notice of a hearing scheduled for October 24, 2019 on whether the employer's request to reopen should be allowed and, if so, the merits of decision # 115234. On October 24th, ALJ Shoemake conducted a hearing at which claimant failed to appear, and on October 31, 2019 issued Order No. 19-UI-139033, allowing the employer's request to reopen and affirming decision # 115234 by concluding the employer suspended claimant, but not for misconduct. On November 8, 2019, the employer filed an application for review of Order No. 19-UI-139033 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). However, even if EAB considered the employer's argument, the outcome of this decision would remain the same for the reasons stated in Order No. 19-UI-139033.

On *de novo* review of the entire hearing record and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-139033 is affirmed.
