

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1065

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 20, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide earnings information requested by the Department for the week of September 1 through 9, 2019, and therefore was denied benefits for that week and until claimant provided that information (September 20th decision). On October 10, 2019, the decision became final without claimant having filed a request for hearing. On October 11, 2019, claimant filed a late request for hearing. On October 15, 2019, ALJ Kangas issued Order No. 19-UI-138042, dismissing claimant's request for hearing as untimely without a showing of good cause, subject to claimant's right to renew his request by responding to an appellant questionnaire by October 29, 2019. On October 25, 2019, claimant responded to the appellant questionnaire. ALJ Kangas reviewed claimant's response and on October 29, 2019, issued Order No. 19-UI-138878, re-dismissing claimant's late request for hearing. On November 6, 2019, claimant filed timely applications for review of Order No. 19-UI-138878 with the Employment Appeals Board (EAB).

EAB considered the hearing record and claimant's written arguments to the extent they were relevant and based on the record.

CONCLUSIONS AND REASONS: Order No. 19-UI-138878 is reversed, and this matter is remanded for a hearing on whether claimant's late request for hearing on the September 20th decision should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In claimant's request for hearing, claimant indicated that his request for hearing was late because "I missed [the] appeal date by one day as I am having surgery that has complicated my ability..." Exhibit

2. Claimant's statement suggests that claimant may have filed his request for hearing late due to factors beyond his reasonable control, and the timing of his request suggests that he filed a request for hearing within seven days after the circumstances that prevented a timely filing ceased to exist. Claimant therefore may have had good cause for filing his request for hearing late, and may have filed it within a reasonable time. However, further inquiry is needed to make that determination, including how the surgery or need for surgery interfered with claimant's ability to file a timely request for hearing.

Orders No. 19-UI-138878 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing on the September 20th decision should be allowed. Only if claimant establishes that he did would he then become entitled to a hearing on the merits of that decision.

DECISION: Order No. 19-UI-138878 is set aside, and this matter remanded for further proceedings consistent with this order.
