EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-1068

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On September 23, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant benefits for the week of August 25 through 31, 2019 because claimant failed to complete a required Reemployment and Eligibility Assessment. On October 15, 2019, the Department's decision became final without claimant having filed a request for hearing. On October 21, 2019, claimant filed a late request for hearing that included a written statement explaining why the request was late. On October 24, 2019, ALJ Kangas issued Order No. 19-UI-138613, denying claimant's request for hearing as late without good cause. On November 6, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered the entire hearing record and claimant's written argument when reaching this decision. In his argument, claimant conceded that he did not personally receive the Department's decision in time to file a timely request for hearing because he failed to notify the Department that his address had temporarily changed, or check his mail at his permanent address more often. However, claimant argued that those were excusable mistakes, and that his late request for hearing therefore should be allowed.

As noted in Order No. 19-UI-138613, however, good cause for filing a late request for hearing does not include the failure to receive a document due to not notifying the Department of an updated address while the person is claiming benefits. Although claimant's failure to check his mail at his permanent address more often was a mistake, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply. Claimant's late request for hearing therefore is subject to dismissal.

On *de novo* review of the entire hearing record and pursuant to ORS 657.275(2), the order under review is **adopted**.
