

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1071**

*Affirmed*  
*Late Request for Hearing Dismissed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On August 8, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, not for misconduct, and claimant qualified to receive unemployment insurance benefits (decision # 121314). On August 28, 2019, decision # 121314 became final without the employer having filed a request for hearing. On September 5, 2019, the employer filed a late request for hearing. On September 10, 2019, ALJ Kangas issued Order No. 19-UI-136293, dismissing the employer's late request for hearing as untimely without a showing of good cause, subject to the employer's right to renew the request by responding to an appellant questionnaire by September 30, 2019. On September 24, 2019, the employer responded to the appellant questionnaire. On October 10, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 23, 2019. On October 23, 2019, ALJ M. Davis conducted a hearing, and on October 24, 2019 issued Order No. 19-UI-138624, re-dismissing the employer's late request for hearing. On November 12, 2019, the employer filed an application for review of Order No. 19-UI-138624 with the Employment Appeals Board (EAB).

EAB considered the hearing record and the employer's written arguments to the extent they were relevant and based on the hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-138624 is affirmed.
