

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1075

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 11, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision that denied claimant benefits, concluding that claimant quit working for the employer without good cause (decision # 102320). On July 31, 2019, decision # 102320 became final without claimant having filed a request for hearing. On September 22, 2019, claimant filed a late request for hearing that included a written statement explaining why the request was late. On September 25, 2019, ALJ Kangas issued Order No. 19-UI-137070, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 9, 2019. On October 8, claimant faxed a response. ALJ Kangas considered claimant's response, and on October 17, 2019 issued Order No. 19-UI-138292, re-dismissing claimant's request for hearing on decision # 102320 as late without a showing of good cause. On November 6, 2019, claimant filed an application for review of Order No. 19-UI-138292 with the Employment Appeals Board (EAB).

Claimant submitted written argument with his application for review. However, EAB did not consider claimant's argument because it was not relevant to the only issue before EAB, which is whether claimant's late request for hearing on decision # 102320 should be allowed.

CONCLUSIONS AND REASONS: Order No. 19-UI-138292 is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 102320 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. Good cause includes the failure to receive a document because the Department mailed it to an incorrect address despite having the correct address. OAR 471-040-0010. Good cause does not include the failure to receive a document due to not notifying the Department of an updated address while the

person is claiming benefits or if the person knows, or reasonably should know, of a pending appeal.
OAR 471-040-0010.

Order No. 19-UI-138292 re-dismissed claimant's late request for hearing on decision # 102320, stating that claimant did not provide any information why he filed his hearing request late. In his request for hearing, however, claimant stated that, "I did not receive letters going to a divorce then separated not living at the address you have . . . just found out about this claim . . ." Exhibit 2. That suggests that claimant may not have become aware of decision # 102320 in time to file a timely request for hearing due to factors beyond his reasonable control, or possibly an excusable mistake, and that he filed his request for hearing within seven days after the factors that prevented timely filing ceased to exist. However, further inquiry is needed into the facts necessary for a determination of those issues. Order No. 19-UI-138292 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 102320 should be allowed and, if so, the merits of that decision.

DECISION: Order No. 19-UI-138292 is set aside, and this matter remanded for further proceedings consistent with this order.
