

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1118**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On October 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause (decision # 112837). On October 15, 2019, claimant filed a timely request for hearing. On October 16, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 30, 2019. On October 30, 2019, ALJ Janzen conducted a hearing, and on October 31, 2019 issued Order No. 19-UI-139029, affirming the Department's decision. On November 20, 2019, Order No. 19-UI-139029 became final without claimant having filed an application for review with Employment Appeals Board (EAB). On November 25, 2019, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 19-UI-139029 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

On November 25, 2019, the appellant filed an application for review of Order No. 19-UI-139029 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than November 20, 2019. The application for review therefore was late, and although the appellant included a written statement with their application for review, that statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed November 25, 2019 is dismissed. Order No. 19-UI-139029 remains undisturbed.
