

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1131**

*Affirmed*  
*Late Request to Reopen Dismissed*

**PROCEDURAL HISTORY:** On July 25, 2019, the Oregon Employment Department (the Department) served seven notices of seven administrative decisions, six concluding that claimant was disqualified from receiving unemployment insurance benefits for refusing six offers of suitable work without good cause (decisions # 95637, 95234, 94906, 94203, 93429 and 85125), and one concluding that claimant was ineligible for benefits from June 2, 2019 to July 20, 2019, because claimant was not available for work (decision # 104527).

On August 6, 2019, claimant filed a timely request for hearing on all seven decisions. On August 16, 2019, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing on all seven decisions, scheduled for August 26, 2019. On August 26, 2019, claimant failed to appear at the hearing, and ALJ Scott issued Orders No. 19-UI-135573 dismissing the request for hearing on decision # 95637, No. 19-UI-135581 dismissing the request for hearing on decision # 95234, No. 19-UI-135580 dismissing the request for hearing on decision # 94906, No. 19-UI-135578 dismissing the request for hearing on decision # 94203, No. 19-UI-135577 dismissing the request for hearing on decision #93429, No. 19-UI-135575 dismissing the request for hearing on decision # 85125, and No. 19-UI-135574 dismissing the request for hearing on decision # 104527, for failure to appear.

On September 16, 2019, Orders No. 19-UI-135573, 19-UI-135581, 19-UI-135580, 19-UI-135578, 19-UI-135577, 19-UI-135575 and 19-UI-135574 became final without claimant having filed a request to reopen the August 26<sup>th</sup> hearing. On November 25, 2019, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on November 26, 2019, issued Orders No. 19-UI-140353, 19-UI-140354, 19-UI-140366, 19-UI-140364, 19-UI-140370, 19-UI-140381 and 19-UI-140389, dismissing the request. On December 4, 2019, claimant filed timely applications for review of Orders No. 19-UI-140353, 19-UI-140354, 19-UI-140366, 19-UI-140364, 19-UI-140370, 19-UI-140381 and 19-UI-140389, with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-140353, 19-UI-140354, 19-UI-140366, 19-UI-140364, 19-UI-140370, 19-UI-140381 and 19-UI-

140389. For case-tracking purposes, this decision is being issued in septuplicate (EAB Decisions 2019-EAB-1131, 2019-EAB-1132, 2019-EAB-1133, 2019-EAB-1134, 2019-EAB-1135, 2019-EAB-1136 and 2019-EAB-1137).

EAB reviewed all seven hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 19-UI-140353, 19-UI-140354, 19-UI-140366, 19-UI-140364, 19-UI-140370, 19-UI-140381 and 19-UI-140389 are affirmed.
