

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1143**

*Order No. 19-UI-139907 Affirmed – Request to Reopen Denied*  
*Order No. 19-UI-136877 Affirmed – No Disqualification*

**PROCEDURAL HISTORY:** On August 19, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision that denied claimant benefits, concluding that the employer discharged claimant for misconduct (decision # 154046). Claimant filed a timely request for hearing. On August 29, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 12, 2019. On September 12<sup>th</sup>, ALJ Snyder conducted a hearing at which the employer failed to appear, and on September 20, 2019 issued Order No. 19-UI-136877, concluding that claimant's discharge was not for misconduct, and did not disqualify claimant from receiving benefits. The employer filed a request to reopen the hearing. ALJ Kangas considered the employer's request, and on November 18, 2019 issued Order No. 19-UI-139907, denying the request.

On November 21, 2019, the employer filed an application for review with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-139907 and 19-UI-136877. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-1111 and 2019-EAB-1143).

With its application for review, the employer submitted, for the first time, information regarding its failure to appear at the September 12<sup>th</sup> hearing. However, the employer failed to show that factors or circumstances beyond its reasonable control prevented it from offering the information into the hearing record with its request to reopen the hearing, as required under OAR 471-040-0040(3) (February 10, 2012). EAB therefore did not consider the employer's new information when reaching this decision. *See* ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019).

The employer also submitted written argument containing new information regarding claimant's discharge. Because the employer failed to establish good cause for failing to appear at the September 12<sup>th</sup> hearing, however, it similarly failed to show that factors or circumstances beyond its reasonable control prevented it from appearing at the hearing and offering information regarding claimant's discharge into the record at that time. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB considered the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 19-UI-139907 and 19-UI-136877 are affirmed.
