

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1153**

*Affirmed*  
*Order No. 19-UI-140058 – Late Claim Denied*  
*Order No. 19-UI-140062 – Disqualification*

**PROCEDURAL HISTORY:** On October 9, 2019, the Oregon Employment Department (the Department) served two notices of two administrative decisions, one denied claimant benefits for the period of August 4, 2019 through September 14, 2019 (weeks 32-19 through 37-19), concluding that claimant failed to file a timely claim for those weeks (decision # 71811), and the other denied benefits for the same time period, because claimant was not actively seeking work (decision # 72538). On November 1, 2019, the Department served notice of an administrative decision which replaced decision # 72538, concluding that claimant was not actively seeking work for the period of August 18 through 24, 2019 (week 34-19), and denied claimant benefits for that week (decision # 102541). Claimant filed a timely request for hearing on decisions # 71811 and # 102541. On November 5, 2019, the Office of Administrative Hearings (OAH) served, by mail, notice of a consolidated hearing scheduled for November 15, 2019 at 3:30 p.m. On November 15, 2019, ALJ Wyatt conducted a consolidated hearing, and on November 20, 2019 issued Order No. 19-UI-140058, affirming decision # 71811, and No. 19-UI-140062 affirming decision # 102541. On December 6, 2019, claimant filed timely applications for review of both Orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-140058 and No. 19-UI-140062. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-1152 and 2019-EAB-1153).

Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond his reasonable control prevented him from offering the information during the hearing. Claimant's written argument also contained information regarding his work separation. However, that information is not relevant to the determination of the issues before EAB, whether claimant actively sought work for the week of 34-19, and whether he filed his claim for benefits for the weeks of 32-19 through 37-19, in a timely manner. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 19-UI-140062 and No. 19-UI-140058 are affirmed.
