EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-1160

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 3, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and claimant was disqualified from receiving unemployment insurance benefits (decision # 141930). On April 23, 2019, decision # 141930 became final without claimant having filed a request for hearing. On November 2, 2019, claimant filed a late request for hearing. On November 12, 2019, ALJ Kangas issued Order No. 19-UI-139533, dismissing claimant's late request for hearing as without good cause, subject to the right to renew the request by responding to an appellant questionnaire by November 26, 2019. On November 29, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-139533 with the Employment Appeals Board (EAB). On December 10, 2019, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was filed late, it would not be considered, another order would not be issued, and Order No. 19-UI-139533 remained in effect. This matter is before EAB based upon claimant's timely November 29th application for review.

EAB considered claimant's response to the appellant questionnaire under OAR 471-041-0090(1) (May 13, 2019). Claimant's response to the appellant questionnaire has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects the admission of EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) Claimant received decision # 141930 on or about April 7, 2019. *See* EAB Exhibit 1 at 1.

(2) Decision #141930 stated that to be timely, any appeal from the decision had to be filed on or before April 23, 2019. Exhibit 1. Claimant did not file a request for hearing until November 2, 2019.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 141930 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Here, claimant filed their request for hearing on decision # 141930 six months after the filing deadline. In claimant's response to the appellant questionnaire, claimant asserted that claimant filed a late request for hearing because when claimant received decision # 141930 "I didn[']t think it was necessary as I was starting a new business at the time." EAB Exhibit 1 at 2. Furthermore, claimant stated that claimant filed a late request for hearing on November 2, 2019, because claimant was being denied benefits for a "new claim" as a result of decision # 141930. EAB Exhibit 1 at 2. Claimant's statement suggest that claimant did not understand the implications of decision # 141930 when claimant received it. It is not good cause to file a late request for hearing because claimant did not understand the implications of the decision the Department mailed claimant and claimant received. OAR 471-040-0010(1)(b)(B). Claimant therefore did not show good cause to extend the filing period for decision # 141930, and claimant's late request for hearing on decision # 140642 therefore is dismissed.

DECISION: Order No. 19-UI-139533 is affirmed.
