

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1161

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On October 10, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision that allowed claimant benefits, concluding that she quit working for the employer with good cause (decision # 62313). The employer filed a request for hearing. On November 12, 2019, ALJ Kangas issued Order No. 19-UI-139549, dismissing the employer's request for hearing as late without good cause, subject to the employer's right to renew the request by responding to an appellant questionnaire by November 26, 2019. On November 27, 2019, the employer filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-139549 with the Employment Appeals Board (EAB). On December 12, 2019, ALJ Kangas issued a letter stating that because the employer's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 19-UI-139549 remained in effect.

EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the employer's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) The employer delayed filing a request for hearing on decision # 62313 because it was waiting to see if claimant filed a lawsuit against the employer. EAB Exhibit 1.

(2) On October 29, 2019, the employer drafted a request for hearing, which it mailed to the Department. Exhibit 2. The postmarked date affixed to the envelope by the United States Postal Service (USPS) is November 4, 2011. Exhibit 2.

(3) Claimant did not file a lawsuit against the employer until after the employer appealed decision # 62313. EAB Exhibit 1.

CONCLUSIONS AND REASONS: The employer's late request for hearing on decision # 62313 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In its response to the appellant questionnaire, the employer asserted that it filed its request for hearing on decision # 62313 on October 29, 2019, which would have been timely. EAB Exhibit 1. However, although the record shows that the employer drafted its request for hearing on October 29th, it also shows that the employer mailed its request for hearing to the Department, and that the postmarked date affixed to the envelope by the USPS is November 4, 2019. Exhibit 2. When a request for hearing is filed by mail, the date of filing is the postmarked date affixed by the USPS. OAR 471-040-0005(4)(b) (July 15, 2018). The employer therefore filed its request for hearing on November 4th, which was 5 days late.

The employer filed its request for hearing late because it was waiting to see if claimant filed a lawsuit against the employer. However, claimant did not file a lawsuit against the employer until after the employer filed its late request for hearing, and the employer failed to show that it was beyond its reasonable control to file its request 5 days earlier. And although the employer's delay in filing its request for hearing was a mistake, it was not an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

The employer's request for hearing on decision # 62313 therefore is dismissed as without good cause.

DECISION: Order No. 19-UI-139549 is affirmed.
