

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1164**

*Affirmed*  
*Overpayment, No Penalties*

**PROCEDURAL HISTORY:** On October 17, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$1,522 overpayment, \$456.60 monetary penalty, and 10 penalty weeks (decision # 194608). Claimant filed a timely request for hearing. On November 22, 2019, ALJ Murdock conducted a hearing at which the employer failed to appear, and on November 26, 2019, issued Order No. 19-UI-140383, modifying the Department's decision by assessing a \$1,522 overpayment, but no penalties. On December 10, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

**Claimant's Written Argument.** Claimant asked EAB to reverse the overpayment because she alleges she was "still owed that amount of unemployment benefits" for January and February 2019, during which time she was unemployed and would have been able to claim unemployment benefits if her benefits had not already "run out." Claimant's Written Argument. Even assuming claimant met all other eligibility requirements to receive benefits for the weeks she asserted she would have claimed in January and February 2019, EAB does not have jurisdiction to take an overpayment from the weeks at issue in Order No. 19-UI-140383 and apply it in some manner to subsequent weeks that were not at issue in the hearing. Claimant is liable to repay \$1,522 to the Department or have it deducted from future benefits otherwise payable. She is not liable for a monetary penalty or penalty weeks.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-140383 is affirmed.
