

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1170

Affirmed
No Disqualification

PROCEDURAL HISTORY: On October 22, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant not for misconduct (decision # 65300). The employer filed a timely request for hearing. On November 19, 2019, ALJ Murdock conducted a hearing, and on November 25, 2019, issued Order No. 19-UI-140282, concluding claimant voluntarily left work with good cause. On December 13, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EMPLOYER'S WRITTEN ARGUMENT: The employer submitted written argument with its application for review. The employer asserted that claimant "voluntarily chose to go to on call," and that the employer offered claimant work, but claimant did not accept it. Employer's Written Argument. The employer alleged at hearing that claimant refused some shifts in August 2018. Claimant did not dispute that she may have refused shifts in August 2018. However, the record shows that the employer did not assign claimant any shifts from when the employer restructured its pharmacy department on September 19, 2018, until claimant's employment ended on November 28, 2019. The record also shows that the restructuring and competition for hours among the pharmacists who were not "floaters" like claimant caused claimant to lose hours, and that the lack of work was likely to continue indefinitely. Claimant's lack of work and loss of income created a grave situation for her, and no reasonable and prudent person in claimant's situation would have continued to work for their employer for an additional period of time rather than quit work and earn their accrued vacation pay.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-140282 is affirmed.
