

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1174**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On April 22, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant but not for misconduct (decision # 115700). The employer filed a timely request for hearing. On May 17, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for May 30, 2019, at which claimant failed to appear. On June 7, 2019, ALJ S. Lee issued Order No. 19-UI-131309, concluding the employer discharged claimant for misconduct. On November 12, 2019, claimant filed a late request to reopen the May 30, 2019 hearing. On May 21, 2019, OAH mailed notice of a hearing scheduled for December 6, 2019. On December 6, 2019, ALJ S. Lee conducted a hearing, and on December 12, 2019 issued Order No. 19-UI-141151, concluding claimant showed good cause to reopen the hearing, and that the employer discharged claimant but not for misconduct. On December 18, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** The appellant's application for review should be dismissed.

On December 18, 2019, the Employment Appeals Board (EAB) received from the appellant what appears to be an application for review of an order that *allowed* the appellant benefits. The appellant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling the appellant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon the appellant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before us presents no justiciable controversy, the application for review of Order No. 19-UI-141151 is dismissed. Order No. 19-UI-141151 remains undisturbed.

**DECISION:** The application for review filed December 18, 2019 is dismissed. Order No. 19-UI-141151 remains undisturbed.
