# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-1175

Affirmed
Ineligible Weeks 40-19 and 41-19

**PROCEDURAL HISTORY:** On October 23, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was ineligible to receive benefits for the period beginning September 29, 2019 and continuing until the reason for the denial had ended because claimant failed to register for work in accordance with the Department's rules. Claimant filed a timely request for hearing. On November 19, 2019, ALJ Monroe conducted a hearing, and on November 27, 2019 issued Order No. 19-UI-140466, modifying the Department's decision by concluding claimant was ineligible for benefits for the weeks including September 29 through October 12, 2019 for the same reason. On December 17, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument to the extent it was based on the hearing record.

**FINDINGS OF FACT:** (1) On September 17, 2019, claimant filed an initial claim for unemployment insurance benefits.

- (2) On September 19, 2019, the Department mailed to claimant UI Publication 277, a letter that notified him that to be eligible for benefits he was required to register for work in the Department's online iMatchSkills system and visit a local WorkSource Oregon Center in person to complete a welcome process. The letter set a deadline for completing those activities of October 4, 2019. The letter notified claimant that if he did not complete the required activities by that date, he would be denied benefits.
- (3) Claimant received UI Publication 277, but "misread" it. Transcript at 13-15. He mistakenly believed he was required to either register online with iMatchSkills or go to a local WorkSource Oregon Center in person to complete the process, but not both. Although he registered for work in the online iMatchSkills system by October 4, 2019, he did not visit a local WorkSource Oregon Center in person and complete the welcome process by that date.

- (4) Claimant claimed benefits for each of the weeks including September 29 through October 12, 2019 (weeks 40-19 and 41-19). Claimant did not receive benefit payments for those weeks because he had not yet completed the in-person welcome process by October 12, 2019.
- (5) Shortly thereafter, claimant received another letter from the Department informing him that to be eligible for benefits, he had to both register for work in the Department's online iMatchSkills system and visit a local WorkSource Oregon Center in person to complete the welcome process. After reading that letter carefully, claimant understood that he had not yet completed the required in-person welcome process at a local WorkSource Oregon Center. However, claimant had just begun a new job and was not able to complete the welcome process until October 28, 2019. Claimant did not claim benefits for any weeks after October 12, 2019.

**CONCLUSIONS AND REASONS:** Claimant failed to register for work in accordance with the Department's rules until after the weeks including September 29 through October 12, 2019 and is ineligible for benefits for those weeks.

ORS 657.155(1)(a) states that an unemployed individual is eligible to receive benefits only if the individual has registered for work and thereafter continued to report at an employment office in accordance with Department rules. ORS 657.159 states that to satisfy the registration requirement of ORS 657.155(1) an individual shall submit such information regarding the individual's job qualifications, training and experience as the Department requests. OAR 471-020-0020(1)(a) (August 8, 2004) states with limited exceptions, none of which are applicable here, that all claimants for unemployment insurance benefits shall comply with the instructions of the Department in providing such information as may be required to carry out job placement services.

Although on September 19, 2019 the Department mailed to claimant UI Publication 277, a letter which presented detailed instructions regarding how to register for work and complete other required enrollment activities to remain eligible for unemployment benefits, claimant did not complete all of those activities by the October 4, 2019 deadline stated therein. Claimant admitted that he received that letter, but "misread" it and mistakenly believed that he was not required to complete the in-person welcome process if he completed his online registration with iMatchSkills, which he did by October 4, 2019. Transcript at 15. It was only after receiving another letter from the Department explaining that both the online iMatchSkills registration and the in-person welcome process were required did claimant understand that it remained necessary for him to complete the welcome process. However, because claimant had just begun a new job, he was not able to complete the in-person welcome process until October 28, 2019.

Although the record shows that claimant's failure to timely complete the required enrollment activities and welcome process was not intentional, no statute or regulation provides exceptions to the Department's registration requirements even if there was good cause for claimant's failure to register or it was the result of a mistake. Since claimant did not register for work as instructed by the Department and there are no applicable exceptions to the registration requirements, claimant is ineligible for benefits for the weeks including September 29 through October 12, 2019 (weeks 40-19 and 41-19).

**DECISION:** Order No. 19-UI-140466 is affirmed.
