

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1176

Affirmed
Ineligible

PROCEDURAL HISTORY: On October 16, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision that denied claimant benefits for the week of October 6 through 12, 2019, concluding that claimant was not available for work that week (decision # 84007). Claimant filed a timely request for hearing. On December 2, 2019, ALJ Snyder conducted a hearing, and on December 10, 2019 issued Order No. 19-UI-140932, affirming the Department's decision. On December 16, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered the entire hearing record and claimants' written argument to the extent it was based on the hearing record and relevant to whether claimant was available for work during the week at issue. In his argument, claimant asserted that Order No. 19-UI-140932 concluded he was not available for work because he was outside his labor market, in Mexico, during the week at issue, and therefore incapable of reporting for work "immediately" if offered work in his labor market.¹ Claimant further asserted that given the type of work he is seeking, it is "rare" to be asked to start work immediately, and that if he was asked to do so, he "would have caught the first flight home."²

However, claimant's argument overlooks that Order No. 19-UI-140932 concluded he was not available for work under OAR 471-030-0036(3)(i)(B) (December 8, 2019). OAR 471-030-0036(3)(i) states, in relevant part, that an individual is not available for work in any week claimed if the individual resides or spends the major portion of the week in a country not included in the Compact of Free Association with the United States of America. OAR 471-030-0036(3)(i)(B). It is undisputed that during the week at issue, claimant resided or spent the majority of the week at issue in Mexico, which is not included in the Compact of Free Association with the United States of America. Order No. 19-UI-140932 therefore correctly determined that claimant was not available for work during the week at issue.

On *de novo* review and pursuant to ORS 657.275(2), Order No. 19-UI-140932 is **adopted**.
