# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-1178

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On November 30, 2006, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$3,393 overpayment and 26 penalty weeks. On December 20, 2006, that decision became final without claimant having filed a timely request for hearing. On November 15, 2019, almost 13 years late, claimant filed a request for hearing. On November 20, 2019, ALJ Kangas issued Order No. 19-UI-140007, dismissing claimant's late request for hearing subject to his right to renew the request by responding to an appellant questionnaire by December 4, 2019. On December 10, 2019, claimant returned a late response to the appellant questionnaire to the Office of Administrative Hearings (OAH) and a timely application for review with the Employment Appeals Board (EAB). On December 18, 2019, ALJ Kangas mailed a letter stating that OAH would not consider claimant's late response. This matter is before EAB based upon claimant's December 10, 2019 application for review.

EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDINGS OF FACT:** In October 2019, claimant received a phone call from the Department during which he learned of the overpayment. *See* EAB Exhibit 1, answer to nos. 1, 5. On November 15, 2019, claimant filed a late request for hearing by telephone. *See* DR Exhibit 2.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing should be dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The circumstances that resulted in claimant not filing a timely request for hearing in this matter might have amounted to good cause. Regardless of whether or not good cause exists, however, claimant's late request for hearing must also be filed within "a reasonable time," which is defined as seven days after the factors that caused the untimely filing ceased to exist.

In this case, claimant wrote on his appellant questionnaire that he found out about the administrative decision during a phone call that occurred in October 2019. Even assuming he received that call on the last day of October, October 31<sup>st</sup>, the latest date to which the filing period could be extended under the seven-day reasonable time rule would be November 7<sup>th</sup>. Claimant did not file his late request for hearing until eight days after that date, on November 15<sup>th</sup>. Claimant therefore did not file his late request for hearing within a reasonable time, and his late request for hearing must be dismissed.

**DECISION:** Order No. 19-UI-140007 is affirmed.
