

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-1180**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On October 30, 2019, the Oregon Employment Department (the Department) served two notices of two administrative decisions, one denied claimant benefits beginning September 15, 2019, concluding that claimant quit working for Tradewinds Enterprises Inc., without good cause (decision # 75056), and the other denied claimant benefits beginning October 13, 2019, concluding that claimant quit working for Automotive Products, Inc., without good cause (decision # 81638). Claimant filed a timely request for hearing on both decisions. On November 25, 2019, ALJ Wyatt conducted two hearings, and on December 2, 2019, issued Order No. 19-UI-140530, affirming decision # 75056, and Order No. 19-UI-140532, affirming decision # 81638. On December 15, 2019, claimant filed timely applications for review of both orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-140530 and No. 19-UI-140532. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-1179 and 2019-EAB-1180).

EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Order No. 19-UI-140532 and Order No. 19-UI-140530 are affirmed.
