

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1181

Affirmed
No Disqualification

PROCEDURAL HISTORY: On November 4, 2019, the Oregon Employment Department (the Department) served notice of three administrative decisions that allowed claimant benefits, decision # 110149 concluding that claimant had good cause to refuse the employer's offer of work on August 28, 2019, decision # 111111 concluding that claimant had good cause to refuse the employer's offer of work on September 9, 2019, and decision # 111532 concluding that claimant had good cause to refuse the employer's offer of work on September 24, 2019. The employer filed timely requests for hearing on all three decisions.

On November 20, 2019, the Office of Administrative Hearings (OAH) scheduled a consolidated hearing on decisions # 110149, 111111 and 111532 for December 5, 2019. On November 22, 2019, the Department served notice of administrative decisions # 85441 and 102407, canceling decisions # 110149 and 111532 by amending them to deny claimant benefits, concluding that claimant did not have good cause to refuse the employer's offers of work on August 28, 2019 and September 24, 2019. On December 25, 2019, the Department issued Orders Nos. 2019-UI-01859 and 2019-UI-01860, dismissing the employer's requests for hearing on decisions # 110149 and 111532 because they were canceled by decisions # 85441 and 102407.

On December 5, 2019, ALJ Monroe conducted a hearing on decision # 111111 at which claimant failed to appear, and on December 12, 2019 issued Order No. 19-UI-141146, affirming decision # 111111 by concluding that claimant did not receive an offer of work from the employer on or about August 28, 2019. On December 19, 2019, the employer filed a timely application for review of Order No. 19-UI-141146 and written argument with the Employment Appeals Board (EAB).

EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). Even if EAB had considered the employer's written argument, the outcome of his decision would remain the same. In their argument, the employer asserted they offered claimant work on September 9, 2019, and that claimant's failure to appear at the December 5, 2019 hearing on decision # 111111 should result in her "request for

unemployment” being denied.¹ However, the record supports Order No. 19-UI-141146’s determination that the employer’s communication with claimant on September 9th was a follow up to an offer of work the employer made, and claimant accepted, on or about August 27, 2019, and not a new or separate offer of work.² Claimant was not required to appear at the December 5th hearing, and her failure to appear is not material to whether she should be disqualified from receiving benefits.³

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), Order No. 19-UI-141146 is **adopted**.

DECISION: Order No. 19-UI-141146 is affirmed.
