

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1187

Affirmed
Disqualification

PROCEDURAL HISTORY: On October 21, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause. (decision #100751). Claimant filed a timely request for hearing. On November 6, 2019 and November 26, 2019, ALJ Frank conducted a hearing, and on December 4, 2019 issued Order No. 19-UI-140677, affirming decision #100751. On December 20, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument when reaching this decision. Claimant's written argument requested the production of a voice mail recording she left on the employer's phone on August 23, 2019. Any party may request that EAB consider additional evidence, but EAB may only allow such a request when the party offering the additional evidence establishes that the additional evidence is relevant and material to EAB's determination and factors or circumstances beyond the party's reasonable control prevented the party from offering the additional evidence into the hearing record. OAR 471-041-0900(A)(b)(B). Claimant did not establish that factors beyond her reasonable control prevented her from offering the voice mail recording into evidence. The record did not show that claimant mentioned the need for it during the first hearing on November 6, 2019, or requested that it be admitted into the hearing record. EAB considered the rest of claimant's written argument to the extent it was based on the hearing record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-140677 is affirmed.
