

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-1194

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On May 31, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily left work without good cause and was disqualified from benefits effective February 3, 2019 (decision # 91434). Claimant filed a timely request for hearing. On June 24, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 8, 2019, at which time claimant failed to appear. On July 8, 2019, ALJ Scott issued Order No. 19-UI-132872, dismissing claimant's request for hearing for failure to appear. On July 29, 2019, Order No. 19-UI-132872 became final without claimant having filed a timely request to reopen the July 8th hearing. On November 1, 2019, claimant filed a late request to reopen. ALJ Kangas reviewed claimant's late request, and on November 4, 2019 issued Order No. 19-UI-139207, denying the request. On November 25, 2019, Order No. 19-UI-139207 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 27, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On December 27, 2019, the appellant filed an application for review of Order No. 19-UI-139207 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than November 25, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although claimant included a written statement with his application for review, the statement did not include any information explaining why claimant waited until December 27th to file his application for review after the filing deadline expired. Because claimant did not file his application for review within the time period allowed, and did not establish that he had good cause to file a late application for review, the application for review must be dismissed.

DECISION: The application for review filed December 27, 2019 is dismissed. Order No. 19-UI-139207 remains undisturbed.
