

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0006**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On November 12, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work from September 8, 2019 through October 12, 2019, and was ineligible for unemployment insurance benefits for that period of time (decision # 103014). On November 15, 2019, claimant filed a timely request for hearing. On November 20, 2019, the Office of Administrative Hearings (OAH) served, by mail, notice of a hearing scheduled for December 5, 2019 at 1:30 p.m. On December 5, 2019, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 19-UI-140761, dismissing claimant's request for hearing for failure to appear. Claimant filed a timely request to re-open the hearing. ALJ Kangas reviewed claimant's request, and on December 18, 2019 issued Order No. 19-UI-141381, denying the request. On January 3, 2020, claimant filed an application for review of Order No. 19-UI-141381 and written argument with the Employment Appeals Board (EAB).

Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record with their request to reopen the December 5<sup>th</sup> hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-141381 is affirmed.
