EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0009

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On September 20, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision #93044). On October 9, 2019, claimant requested a hearing. On October 11, 2019, the Office of Administrative Hearings (OAH) issued notice of a hearing scheduled for October 25, 2019 at 1:30 p.m. Claimant failed to appear for the October 25, 2019 hearing. On October 25, 2019, ALJ Frank issued Order No. 19-UI-138746, dismissing claimant's appeal due to his failure to appear. On November 14, 2019, Order No. 19-UI-138746 became final without claimant having filed a timely request to reopen or an application for review with the Employment Appeals Board (EAB). On November 19, 2019, claimant filed a request to reopen the hearing. On November 26, 2019, OAH issued notice of a hearing scheduled for December 11, 2019 at 9:30 a.m. On December 11, 2019, ALJ Frank conducted a hearing, and on December 19, 2019, issued Order No. 19-UI-141459, concluding that claimant did not demonstrate good cause for reopening the hearing. On January 3, 2020, claimant filed an application for review of Order No. 19-UI-141459 with EAB.

FINDINGS OF FACT: (1) Claimant received the notice of hearing OAH mailed, which scheduled a hearing for October 25, 2019 at 1:30 p.m. Claimant planned to attend the hearing.

- (2) On October 25, 2019 claimant accompanied his father to two doctor appointments scheduled for 9:30 a.m. and 11:30 a.m. respectively. Claimant failed to appear at the hearing at 1:30 p.m. Order No. 19-UI-138746, dismissing claimant's request for hearing due to his failure to appear, became final on November 14, 2019.
- (3) Five days later, on November 19, 2019, claimant filed a request to reopen the hearing. In his request, claimant noted that he failed to appear because he had multiple decisions on appeal and got the dates mixed up.

CONCLUSION AND REASONS: Order No. 19-UI-141459 is affirmed. Claimant failed to demonstrate good cause for his late request to reopen.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. The period within which a party may request reopening may be extended if the party requesting reopening as good cause for failing to request reopening within the time allowed, and acts within a reasonable time. OAR 471-040-0041(1) (February 10, 2012). "Good cause" exists when an action, delay, or failure to act arises from an excusable mistake or from factors beyond an applicant's reasonable control, but "good cause" does not include filing a late request to reopen a hearing due to "[n]ot understanding the implications of a decision or notice when it is received." OAR 471-040-0041(2).

Claimant filed his request to reopen the October 25, 2019 hearing late because he had other appeal matters pending that caused him to confuse their deadline dates with his unemployment insurance benefit appeal deadline date. Claimant's confusion about the deadline is not good cause because the administrative rule defining good cause, above, specifically states that not understanding the implications of a decision or notice when it is received is not good cause. Claimant therefore has not demonstrated good cause for filing a late request to reopen.

The decision in Order No. 19-UI-141459 is affirmed; claimant did not show good cause for his late request to reopen, and decision #93044 remains undisturbed.

DECISION: Order No. 19-UI-141459 is affirmed.
