

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0010**

*Affirmed*  
*Late Claims Denied*

**PROCEDURAL HISTORY:** On October 10, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's late claims for the weeks from August 25, 2019 through September 7, 2019 (decision # 83902). Claimant filed a timely request for hearing. On December 9, 2019, ALJ Griffin conducted a hearing, and on December 16, 2019 issued Order No. 19-UI-141252, affirming the Department's decision. On January 4, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument in reaching this decision. Claimant asserted that his inability as a deaf individual to use the telephone "at a moment's notice" prevented him from completing his claims on time. Claimant had to wait until he was at home to use his telephone to call the Department. However, claimant did not show in his argument or at hearing that he was not able to call the Department, or visit the Department, due to being a deaf individual. The record shows that claimant filed his claims late because he initially believed that he was not eligible for benefits, and later, was working from 7:00 a.m. until 3:30 p.m. or 4:30 p.m. on weekdays. Claimant could have returned home to call the Department or visited the Department after work, or taken time off work to do so. Claimant stated in his argument that rather than stay home to file timely claims, he preferred to "do [his] best to find work." While this is certainly understandable, the applicable administrative rules do not allow for such exceptions to the filing deadlines, and claimant's late claims must be denied.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-141252 is affirmed.
