

**EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0014**

*Affirmed
No Disqualification*

PROCEDURAL HISTORY: On November 7, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, but not for misconduct (decision # 154108). The employer filed a timely request for hearing. On December 19, 2019, ALJ K. Monroe conducted a hearing, and on December 24, 2019 issued Order No. 19-UI-141673, affirming the Department's decision. On January 7, 2020, the employer filed an application for review with the Employment Appeals Board (EAB).

EMPLOYER'S WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). The argument also asked that the employer's owner be permitted to attend a hearing to "make sure his side is heard." At hearing, and in its written argument, the employer stated that the owner did not attend the hearing because he was "unavailable." Transcript at 4. The mere assertion that the owner was unavailable does not show that factors or circumstances beyond the employer's reasonable control prevented them from having the owner testify at the December 19 hearing. Nor does the record show that the employer requested to postpone or continue the hearing so that the owner could attend. For these reasons, EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-141673 is affirmed.
