PROCEDURAL HISTORY: On November 25, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work and denied benefits from November 3, 2019 through November 16, 2019, and until the reason for the denial had ended (decision # 132702). Claimant filed a timely request for hearing. On January 2, 2020, ALJ Scott conducted a hearing, and on January 3, 2020 issued Order No. 20-UI-142056, modifying the Department's decision and concluding claimant was not eligible for benefits from November 3, 2019 through December 14, 2019, but eligible for benefits from December 15, 2019 through December 28, 2019. On January 10, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision. Claimant asserted in her written argument that being required to be available to accept the work she sought on all days, from 5:00 a.m. to 3:00 a.m., was "unreasonable." Department rules, however, specifically define the term "available for work." For an individual to be considered "available for work" for purposes of ORS 657.155(1)(c), they must be "willing to work full time, part time, and accept temporary work opportunities, during *all of the usual hours and days of the week customary for the work being sought * * **" OAR 471-030-0036(3)(a) (December 8, 2019) (italics added). While claimant may have found these requirements frustrating and unreasonable, we agree with the ALJ that Department rules cannot be disregarded.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-142056 is affirmed.
