# EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0032

**Affirmed** Not Eligible Weeks 46-19 through 50-19

PROCEDURAL HISTORY: On December 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from November 10, 2019 through November 30, 2019 and until the reason for the denial had ended (decision #85212). Claimant filed a timely request for hearing. On January 8, 2020, ALJ Roberts conducted a hearing, and on January 9, 2020 issued Order No. 20-UI-142348, modifying<sup>1</sup> the Department's decision and concluding claimant was not available for work from November 10, 2019 through December 14, 2019. On January 14, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written arguments, submitted on her application for review and separately on January 22, 2020. Claimant told the Department on November 18, December 5, and in writing on December 13, 2019, that during the weeks at issue she was limiting her work search to the Eugene and Coburg areas, and was not looking for work in Springfield because she did not have transportation to do so. All the work searches claimant provided the Department when she filed her weekly claims were for work in Eugene. At hearing, claimant confirmed that she was not looking for work in the Springfield area during the weeks at issue. Claimant asserted in her written argument and at hearing that, had she been offered a job in Springfield, she would have accepted the position and "would have found a way" to get to work. Audio Record at 15:13. We find claimant's assertion credible, especially since she accepted work in December 2019 that required her to walk one hour each way. However, to be available for work as defined by Department rules, an individual must be "[c]apable of accepting and reporting for any suitable work opportunities within the labor market in which work is being sought ... and "[n]ot impos[e] conditions which substantially reduce the individual's opportunities to return to work at the earliest possible time." OAR 471-030-0036(3)(b), (c) (December 8, 2019). Claimant's labor market was Eugene, Coburg and Springfield. By limiting her work search primarily to Eugene and Coburg because she was not within walking distance of potential employers in Springfield, claimant imposed a condition which substantially reduced her opportunities to

return to work at the earliest possible time. For these reasons, claimant was not available for work from November 10, 2019 through December 14, 2019, weeks 46-19 through 50-19. Claimant is therefore ineligible to receive unemployment insurance benefits for that period.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-142348 is affirmed.
