EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0033-R

Request for Reconsideration Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On October 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision #153738). Claimant filed a timely request for hearing. On October 24, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for November 6, 2019, at which the claimant failed to appear. On November 7, 2019, ALJ S. Roberts issued Order No. 19-UI-139339, dismissing claimant's request for hearing for failure to appear. On November 18, 2019, claimant filed a timely request to reopen the November 6, 2019 hearing. On November 27, 2019, OAH mailed notice of a hearing scheduled for December 13, 2019. On December 13, 2019, ALJ Wyatt conducted a hearing, and on December 18, 2019, issued Order No. 19-UI-141435, allowing claimant's request to reopen, canceling Order No. 19-UI-139339, and affirming the Department's decision that claimant voluntarily left work without good cause. On January 7, 2020, Order No. 19-UI-141435 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 13, 2020, claimant filed a late application for review with EAB. On January 21, 2020, EAB issued EAB Decision 2020-EAB-0033, dismissing claimant's application for review because claimant provided no explanation as to why claimant filed the application after the filing deadline expired, and therefore did not show good cause to extend the filing deadline. On January 28, 2020, claimant filed a request for reconsideration of EAB Decision 2020-EAB-0033 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: The request for reconsideration is dismissed.

On January 28, 2020, the appellant filed a request for reconsideration with the Employment Appeals Board. A party may request reconsideration of an EAB decision to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rules, positions or practices. ORS 657.290(3); OAR 471-041-0145(1). A reconsideration request is subject to dismissal unless it includes a statement that a copy was provided to the other parties. The appellant's request for reconsideration included no statement that a copy was provided to the other parties. OAR 471-041-0145(2)(a). The reconsideration request is, therefore, dismissed. Even had claimant provided a copy of their request for reconsideration to the other parties, EAB would have re-dismissed claimant's application for review as late without good cause. Claimant stated in their request for reconsideration

that they did not "know the urgency of the situation" and their mail was delivered to a second party. Because the request does not contain sufficient information about claimant's mail to show that it was not within claimant's reasonable control to receive that decision sooner, and because it was within claimant's reasonable control to read that decision and ensure that they understood the appeal deadline, claimant did not show good cause for the late application for review. EAB Decision 20-EAB-0033 remains undisturbed, and EAB will take no further action with regard to this matter.

DECISION: The request for reconsideration filed January 28, 2020 is dismissed. Order No. 19-UI-141435 remains undisturbed.
