EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0048

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On October 17, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision #72938). On November 6, 2019, decision #72938 became final without claimant having filed a timely request for hearing. On November 15, 2019, claimant filed a late request for hearing.

On November 21, 2019, ALJ Kangas reviewed claimant's request and issued Order No. 19-UI-140124, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by December 11, 2019. Claimant timely responded to the questionnaire. On December 10, 2019, the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 19-UI-140124 was vacated and a hearing would be scheduled. On December 23, 2019, OAH mailed notice of a hearing scheduled for January 6, 2020.

On January 6, 2020, ALJ Murdock conducted a hearing at which the employer failed to appear, and on January 10, 2020 issued Order No. 20-UI-142477, re-dismissing claimant's late request for hearing, leaving the Department's October 17, 2019 decision undisturbed. On January 18, 2020, claimant filed a timely application for review of Order No. 20-UI-142477 with the Employment Appeals Board (EAB).

With their application for review, claimant submitted a written argument. Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2). Even if EAB had considered claimant's written argument, this decision would remain the same. Claimant stated in the argument that despite the death of her family member on October 26, 2019, she continued to seek work and file weekly claims for benefits. Audio Record at 11:00 to 14:00. Claimant also stated that she was aware of the November 6, 2019 deadline for requesting

an appeal of the department's decision and, despite some confusion over how to appeal, she was able to request a hearing on November 14, 2019, although it was late. Audio Record at 11:00 to 14:00.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-142477 is affirmed.
