EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0052

*Affirmed
No Disqualification*

PROCEDURAL HISTORY: On November 27, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was discharged for misconduct and benefit rights based on wages earned prior to the date of discharge may not be canceled (decision # 161135). Claimant filed a timely request for hearing. On January 8, 2020, ALJ Janzen conducted a hearing, and on January 9, 2020 issued Order No. 20-UI-142377, concluding claimant was discharged, but not for misconduct.¹ On January 21, 2020, the employer filed an application for review with the Employment Appeals Board (EAB).

The employer's written argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. Moreover, the same information was provided at hearing by way of testimony. EAB considered the remainder of the employer's argument, and claimant's written argument, in reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-142377 is affirmed.

¹ Because no party appealed the issue, Order No. 20-UI-142377 did not address whether the employer discharged claimant for commission of theft in connection with work and whether claimant should have all wage credits prior to the discharge canceled.
