EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0063

Reversed & Remanded

PROCEDURAL HISTORY: On April 11, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was ineligible to receive benefits for the week of March 17 through March 23, 2019 and continuing until the reason for the denial ended because claimant failed to register for work in accordance with the Department's rules. On May 1, 2019, the administrative decision became final without claimant having filed a timely request for hearing. On December 11, 2019, claimant filed a late request for hearing. On December 19, 2019, ALJ Kangas issued Order No. 19-UI-141445, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by January 2, 2020. On January 8, 2020, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 19-UI-141445 by the Employment Appeals Board (EAB). On January 9, 2020, ALJ Kangas mailed a letter to claimant notifying him that his questionnaire response was late and therefore would not be considered. This matter therefore comes before EAB based upon claimant's January 8, 2020 application for review of Order No. 19-UI-141445.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 19-UI-141445 is set aside and this matter remanded.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In his appellate questionnaire response, claimant asserted that he filed a late request for hearing in this case because he had not received the April 11, 2019 denial, was "unaware of the deadline and process back in March/April when original claim was filed" and believed he had good cause for filing his hearing request late for much the same reason, stating, "I was unaware of the Imatch Skills and welcome process back in March/April when original claim was filed." EAB Exhibit 1 at 1-2.

Claimant's appellant questionnaire response suggests that he might have had good cause for filing a late request for hearing in this case. However, additional evidence is necessary before a determination can be reached about whether he had good cause for doing so, and, if so, whether he filed his late request for hearing within the seven-day "reasonable time" period. For example, although claimant asserted that he never received the Department's April 11, 2019 denial letter, record fails to show whether the Department mailed that letter to claimant at his actual address on April 11, 2019 and/or to his address as shown by the records on file with the Department. The record also fails to show when and how claimant became aware of the April 11, 2019 denial, and what steps he took and when he took them to file his late request for hearing.

Order No. 19-UI-141445 therefore is set aside, and this matter remanded to the Office of Administrative Hearings (OAH) for a hearing on the late request for hearing issue. Only if claimant establishes at the hearing that he had good cause for the late request for hearing and that he filed the late request within a reasonable time would he be entitled to a hearing on the merits of the Department's April 11, 2019 decision.

NOTE: The failure of any party to appear at the hearing on remand will not reinstate Order No. 19-UI-141445 or return this matter to EAB. Only a timely application for review of the subsequent order will cause this matter to return to EAB.

DECISION: Order No. 19-UI-141445 is set aside, and this matter remanded for further proceedings consistent with this order.
