

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0064

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 18, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from November 17, 2019 through November 23, 2019 (decision # 120421). Claimant filed a timely request for hearing. On January 22, 2020, ALJ Turner conducted a hearing, and on January 23, 2020, issued Order No. 20-UI-143187, concluding claimant actively sought work from November 17, 2019, through November 23, 2019. On January 25, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The appellant's application for review should be dismissed.

On January 25, 2020, the Employment Appeals Board (EAB) received from the appellant what appears to be an application for review of an order that *allowed* the appellant benefits. The appellant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling the appellant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon the appellant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before us presents no justiciable controversy, the application for review of Order No. 20-UI-143187 is dismissed. Order No. 20-UI-143187 remains undisturbed.¹

DECISION: The application for review filed January 25, 2020 is dismissed. Order No. 20-UI-143187 remains undisturbed.

¹ Department records show that on January 22, 2020 ALJ Shoemake conducted a hearing on decision # 115720, and on January 30, 2020 issued Order No. 20-UI-143526, which concluded that claimant voluntarily left a job without good cause and was disqualified from benefits effective November 17, 2019. Because that order was issued five days after claimant filed her application for review in this case, the application for review does not apply to that order. If claimant wants EAB to review of Order No. 20-UI-143526, they must file an application for review of that order with EAB.
