EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0065

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 110831). On May 29, 2019, decision # 110831 became final without claimant having filed a timely request for hearing. On September 26, 2019, claimant filed a late request for hearing. On December 17, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 31, 2019. On December 31, 2019, ALJ Scott conducted a hearing, and on January 7, 2020, issued Order No. 20-UI-142163, concluding claimant failed to establish good cause for his late request for hearing and dismissing claimant's September 26, 2019 request for hearing. On January 23, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

With their application for review, claimant submitted a written argument. Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090. EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

Even if EAB had considered claimant's written argument, this decision would remain the same. At hearing, claimant admitted that he had received and read decision # 110831, which disqualified him from receiving benefits, before the appeal deadline. Claimant did not file a timely request for hearing because "the appeal thing, I read that but I really didn't understand because I already had a job and everything...so it really didn't make much sense to me." Audio Record at 20:50 to 21:50. That statement supports the conclusion of Order No. 20-UI-142163 that claimant's failure to understand the implications of decision # 110831 when it was received did not establish good cause for his late request for hearing under OAR 471-040-0010(1)(b)(B). Order No. 20-UI-142163 at 3.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-142163 is affirmed.
