

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0079

Affirmed
Late Request for Hearing Allowed
Overpayment Assessed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 11, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was overpaid \$912 in benefits which she was required to repay to the Department (decision # 194073). The decision stated that any appeal of the decision had to be filed by October 31, 2019 to be timely. On October 31, 2019, decision # 194073 became final without claimant having filed a timely request for hearing. On November 8, 2019, claimant filed a late request for hearing.

ALJ Kangas reviewed claimant's hearing request and on November 18, 2019, issued Order No. 19-UI-139943, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by December 2, 2019. Claimant provided a timely response to the questionnaire. On November 26, 2019, the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 19-UI-139943 was vacated and a hearing would be scheduled to address the timeliness of claimant's hearing request and, if appropriate, the merits of the underlying administrative decision on appeal. On December 24, 2019, OAH mailed notice of a hearing scheduled for January 10, 2020.

On January 10, 2020, ALJ S. Lee conducted a hearing, and on January 22, 2020, issued Order No. 20-UI-143136, allowing claimant's late request for hearing based upon a showing of good cause and modifying decision # 194073 by reducing the overpayment to \$476 in benefits which claimant was required to repay to the Department. On January 27, 2020, claimant filed a timely application for review of Order No. 20-UI-143136 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-143136 is affirmed.
