

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0096**

*Late Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On December 3, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause and was disqualified from benefits effective November 3, 2019 (decision # 104503). Claimant filed a timely request for hearing. On December 26, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for January 9, 2020. On January 9, 2020, ALJ Wymer conducted a hearing, and on January 10, 2020, issued Order No. 20-UI-142415, concluding claimant was discharged for misconduct and was disqualified from benefits effective November 3, 2019. On January 30, 2020, Order No. 20-UI-142415 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 31, 2020, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 20-UI-142415 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

On January 31, 2020, claimant (the appellant) filed an application for review of Order No. 20-UI-142415 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than January 30, 2020. Claimant provided a written statement describing the circumstances that prevented a timely filing. Claimant stated that he filed his application for review late because he misread or misunderstood the deadline for filing an application for review of Order No. 20-UI-142415. Claimant's statement does not show good cause to extend the 20-day filing period. It was within claimant's reasonable control to read Order No. 20-UI-142415 carefully, including the deadline for

filing an application for review of that order. Filing the application for review on time was therefore not prevented by factors or circumstances beyond claimant's reasonable control. Accordingly, the late application for review is dismissed.

**DECISION:** The late application for review filed January 31, 2020 is dismissed. Order No. 20-UI-142415 remains undisturbed.
