EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0098-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On November 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received unemployment insurance benefits to which he was not entitled and assessing a \$3,011 overpayment, a \$903.30 monetary penalty, and a 20-week penalty disqualification from benefits (decision # 193536). Claimant filed a timely request for hearing. On January 9, 2020, ALJ Shoemake conducted a hearing at which the employer failed to appear, and on January 17, 2020, issued Order No. 20-UI-142948, affirming decision # 193536. On February 3, 2020, claimant filed an application for review with the Employment Appeals Board (EAB). On March 12, 2020, EAB issued EAB decision 2020-EAB-0098, affirming Order No. 20-UI-142948. On October 10, 2022, claimant filed a late request for reconsideration of EAB decision 2020-EAB-0098.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument, filed October 20, 2022, when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

FINDING OF FACT: (1) EAB mailed EAB Decision 2020-EAB-0098 to claimant on March 12, 2020. The decision stated that any reconsideration of the decision would be dismissed unless five requirements were met: the request for reconsideration must have been filed within 20 days of the date the decision was mailed; the request must have included a statement that a copy of the request had been mailed to the other party; the request must include additional specific details about the reason the application for review was filed late; the request must have included the date on which the circumstances which prevented them from filing a timely application for review ceased to exist; and the request must have provided sufficient information to prove that the application for review was filed within seven days after those circumstances ceased to exist.

CONCLUSIONS AND REASONS: Claimant's late request for reconsideration of EAB Decision 2020-EAB-0098 is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB Decision 2020-EAB-0098 was mailed to the parties on March 12, 2020. The deadline for claimant to file a timely request for reconsideration was April 1, 2020. Claimant submitted his request for reconsideration on October 10, 2022, which was more than 20 days after EAB Decision 2020-EAB-0098 was mailed. Additionally, the request did not include a statement that a copy of the request for reconsideration was provided to the other party (the employer). For those reasons, claimant's request for reconsideration is subject to dismissal under OAR 471-041-0145(2).

DECISION: The request for reconsideration filed March 12, 2020 is dismissed. EAB Decision 2020-EAB-0098 and Order No. 20-UI-142948 remain undisturbed.
