

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0100

Affirmed
Disqualification

PROCEDURAL HISTORY: On December 18, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct (decision # 115949). The employer filed a timely request for hearing. On January 14, 2020, ALJ Scott conducted a hearing, and on January 17, 2020 issued Order No. 20-UI-142977, reversing Department's decision by concluding that claimant's discharge was for misconduct, and disqualifying claimant from benefits effective December 1, 2019. On February 3, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EVIDENTIARY RULING: Order No. 20-UI-142977 admitted Exhibit 1 during the hearing, and held the record open to receive and admit Exhibit 2 after the hearing, subject to the parties' right to object to admission of Exhibit 2. The record does not include any evidence that either party objected to Exhibit 2 or that the Administrative Law Judge sustained any such objection. Exhibit 2 therefore remains in the record, as set forth in Order No. 20-UI-142977.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-142977 is affirmed.
