

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0109

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not registered following the rules set by the Director (the decision). Claimant filed a timely request for hearing. On January 15, 2020, ALJ Wyatt conducted a hearing, and on January 17, 2020, issued Order No. 20-UI-142926, concluding claimant did not timely submit the required information. On February 6, 2020, Order No. 20-UI-142926 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 7, 2020, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On February 7, 2020, the appellant filed an application for review of Order No. 20-UI-142926 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than February 6, 2020. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed February 7, 2020 is dismissed. Order No. 20-UI-142926 remains undisturbed
