EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0123

Reversed and Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On October 25, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for a disqualifying act and denying benefits beginning June 30, 2019 (decision # 164612). On November 14, 2019, decision # 164612 became final without claimant having filed a request for hearing. On January 2, 2020, claimant filed a late request for hearing. On January 14, 2020, ALJ Kangas issued Order No. 20-UI-142559, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by filing a response to an appellant questionnaire by January 28, 2020. On February 3, 2020, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 20-UI-142559 with the Employment Appeals Board (EAB). On February 10, 2020, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was filed late, it would not be considered, another order would not be issued, and Order No. 20-UI-142559 remained in effect.

This decision is being issued pursuant to claimant's timely application for review of Order No. 20-UI-142559. EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 20-UI-142559 is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 164612 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In his response to the appellant questionnaire, claimant asserted that he filed his request for hearing on decision # 164612 late because he "is homeless living in [his] car," and "[does] not always receive [his] mail on time." EAB Exhibit 1. According to claimant, he did not receive decision # 164612 until January 4, 2020. EAB Exhibit 1.

Claimant's response to the appellant questionnaire suggests he may have filed his request for hearing on decision # 164612 late due to factors beyond his reasonable control or an excusable mistake, or a combination thereof, that he filed his late request for hearing within a reasonable time, and that his request for hearing therefore should be allowed. However, further inquiry is needed into the facts necessary to determine those issues. For example, further inquiry is needed into how claimant received his mail, how often he received his mail, how his homelessness prevented him from receiving his mail sooner and filing a timely request for hearing, and if and when those factors ceased to exist. Further inquiry also is needed into whether claimant knew or reasonably should have known that a decision from the Department on the issue addressed in decision # 164612, or other issues, was pending, such that he should been more diligent in obtaining his mail or communicating with the Department.

Order No. 20-UI-142559 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 164612 should be allowed and, if so, on the merits of that decision.

DECISION: Order No. 20-UI-142559 is set aside, and this matter remanded for further proceedings consistent with this order.
