

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0124

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On August 21, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work during the weeks including July 28, 2019 through August 17, 2019 and until the reason for the denial had ended (decision # 81740). On September 10, 2019, decision # 81740 became final without claimant having filed a timely request for hearing.

On January 13, 2020, claimant filed a late request for hearing. On January 23, 2020, ALJ Kangas reviewed the record and issued Order No. 20-UI-143162, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by February 6, 2020. Claimant timely responded to the appellant questionnaire. ALJ Kangas reviewed claimant's questionnaire response and on February 4, 2020 issued Order No. 20-UI-143854, re-dismissing claimant's late request for hearing after concluding claimant failed to establish good cause for her late request, and leaving decision # 81740 undisturbed. On February 11, 2020, claimant filed a timely application for review of Order No. 20-UI-143854 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-143854 is affirmed.
