

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0132

Affirmed
Disqualification

PROCEDURAL HISTORY: On November 26, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 112617). Claimant filed a timely request for hearing. On January 23, 2020, ALJ Amesbury conducted a hearing, and on January 29, 2020, issued Order No. 20-UI-143489, affirming decision # 112617. On February 12, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument on March 9, 2020, which was timely and considered to the extent it was based upon the hearing record. Claimant submitted a second written argument on March 11, 2020, which was filed 2 days after the deadline. Claimant requested an extension of time to file the written argument, but the request was denied because claimant did not meet the requirements set forth at OAR 471-041-0080 that govern when extension requests may be allowed. Because claimant's argument was not received by EAB within the time period allowed under OAR 471-041-0080(1) (May 13, 2019), and claimant was not entitled to an extension of the deadline, the March 11th argument was not considered by EAB when reaching this decision. OAR 471-041-0080(2)(a).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-143489 is affirmed.
