

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0135

Affirmed
Eligible Week 46-19
Disqualification Effective Week 47-19

PROCEDURAL HISTORY: On December 12, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, not for misconduct (decision # 135218). The employer filed a timely request for hearing. On February 4, 2020, ALJ Roberts conducted a hearing, and on February 6, 2020, issued Order No. 20-UI-144003, modifying the Department's decision and concluding the employer discharged claimant, not for misconduct, within fifteen days of a planned quit without good cause. Order No. 20-UI-144003 further concluded that claimant was eligible for benefits from November 8 through November 21, 2019, but disqualified from receiving benefits effective November 22, 2019 until requalified under Employment Department law.

On February 11, 2020, ALJ Roberts issued Amended Order No. 20-UI-144259, modifying the Department's decision and concluding the employer discharged claimant, not for misconduct, within fifteen days of a planned quit without good cause, but amending claimant's benefit eligibility period and the effective date of her disqualification from benefits stated in Order No. 20-UI-144003. Order No. 20-UI-144259 concluded that claimant was eligible for benefits from November 10 through November 16, 2019 (week 46-19), but disqualified from receiving benefits effective November 17, 2019 (week 47-19) and until requalified under Employment Department law. On February 12, 2020, claimant filed a timely application for review of Order No. 20-UI-144259 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: With her application for review, claimant submitted a written argument. Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-144259 is affirmed.
